## **CABINET OF THE CAYMAN ISLANDS – POST MEETING SUMMARY**

A meeting of the Cabinet was convened on Wednesday, 21<sup>st</sup> January 2026 in the Cabinet Conference Room, Government Administration Building.

All Ministers and Members of Cabinet were present.

At this meeting Cabinet:

- a) Confirmed approval granted by circulation on 16<sup>th</sup> January 2026 the final awardees list to be recognised and awarded on National Heroes Day 2026;
