## **CABINET OF THE CAYMAN ISLANDS – POST MEETING SUMMARY**

A meeting of the Cabinet was convened on Wednesday, 28<sup>th</sup> January 2026 in the Cabinet Conference Room, Government Administration Building.

All Ministers and Members of Cabinet were present.

At this meeting Cabinet:

- a) Approved the issuance of drafting instructions to amend the Health Practice Act (2021 Revision);
- b) Approved pursuant to section 4 of the Mental Health Commission Act (2024 Revision) the following appointments to the Mental Health Commission: Fiona McDougall, Chair; Cline Glidden Jr, Deputy Chair; Dympna Carten, Member; Carla (Jackie) Neil, Member; and Dr. Francisco Martinez-Saborido, Member;
- c) Approved the issuance of a coastal works permit for the construction of a cantilever dock;

- f) Approved the issuance of a coastal works permit for an existing sargassum barrier and extensions to an existing dock;

- k) Approved pursuant to sections 8(4)(e) and 8(6) of the Health Services Authority Act (2018 Revision) the following appointments to the Board of Directors of the Health Services Authority: Timothy Ridley, Director and Chair; Buck Grizzel, Director; Peter Spratt, Director; and Omari Corbin, Director;
- l) Approved pursuant to section 9 of the Public Authorities Act (2020 Revision) the following re-appointments to the National Housing Development Trust Board: Denniston Tibbetts, Deputy Chair; Doey Kelly, Director; Dominic Williams, Director; and Kendal Connor, Director;

- m) Approved adjustments of the 2025 appropriations for the Portfolio of Legal Affairs, which will be reported to Parliament in accordance with sections 11(5) and 11(6) of the Public Management and Finance Act (2020 Revision); and
