## **CABINET OF THE CAYMAN ISLANDS – POST MEETING SUMMARY**

A meeting of the Cabinet was convened on Wednesday, 25<sup>th</sup> March, 2026 in the Cabinet Conference Room, Government Administration Building.

All Ministers and Members of Cabinet were present.

At this meeting Cabinet:

- a) Approved drafting instructions to the Legislative Drafting Department to amend the following legislation in preparation for international evaluations: Companies Act (2026 Revision); Exempted Limited Partnership Act (2025 Revision); Foundation Companies Act (2025 Revision); Limited Liability Companies Act (2025 Revision); Limited Liability Partnership Act (2025 Revision); Partnership Act (2025 Revision); Trusts Act (2021 Revision); Banks and Trust Companies Act (2025 Revision); Companies Management Act (2025 Revision); Mutual Funds Act (2025 Revision); and any other relevant or associated legislation;
- b) Approved drafting instructions to the Legislative Drafting Department to amend the Foundation Companies Act (2025 Revision) and Companies Act 2026 Revision) to provide a statutory mechanism for a foundation company’s secretary (qualified person) to resign;
- c) Approved the proposed new public road in Old Man Bay North Side and publication of the sections 3 and 6 Declarations for Boundary Plan 705;
- d) Approved the proposed new public road in Newlands and publication of the sections 3 and 6 Declarations for Boundary Plan 699;
- e) Approved in accordance with section 4(1) of the Public Transport Appeals Tribunal Regulations, 2025, the following appointments to the Public Transport Appeals Tribunal: Samantha Conolly, Chairperson; Tracey Forbes, Deputy Chairperson; and Yaremis Hydes, Member;
- f) Approved pursuant to section 3 and 4 of the Notaries Public Act (2023 Revision), the appointment of the following individuals as a Notary Public: Lorna S. Carroll; Ronnie Cuthbert; William S. Hinds; and Robert F. Madden;
- g) Approved in accordance with Standing Order 63 of the Parliament Standing Orders, 2025, the Parliament (Management) (Amendment) Bill, 2026 to be tabled in Parliament;
- h) Approved drafting instructions to the Legislative Drafting Department to amend the Health Practice Act (2026 Revision) (Schedule 3) and the Health Practice Regulations (2021 Revision) Section 4(10);
- i) Approved the Health Practice (Amendment) Bill, 2026 to be tabled in Parliament;
- j) Approved drafting instructions to the Legislative Drafting Department to amend the Trade and Business Licensing Act (2021 Revision) and for the creation of Regulations under Section 10 of the Fuel Market Regulation Act (2017);
- k) Approved the execution of lease agreements between the Cayman Islands Airports Authority and relevant Cayman Islands Government entities;

- 1) Approved the Airports Authority (Amendment) Bill, 2026 to be tabled in Parliament.
