

Section 53(1)(b) Exemption Request Form

Section 53(1)(b) of the Immigration (Transition) Act (2022 Revision) ("the Act") enables Cabinet to declare certain people exempt from the provisions contained in Part 7 of the Act, which sets out the restrictions on who may be gainfully employed within the Islands, as well as the term limits for workers.

As a declaration made under section 53(1)(b) constitutes an exemption from the immigration restrictions approved by Parliament, these grants are, by their nature, exceptional. Requests for an exemption are very unlikely to be granted where an applicant has simply failed to meet the eligibility criteria for one of the existing immigration facilities; an applicant will need to demonstrate that the facts surrounding their application give rise to particularly compelling reasons why they ought to be permitted to remain in the Islands in circumstances where they would otherwise be ineligible to do so.

Application Processing:

The WORC Department and/or the Ministry of Border Control, Labour & Culture will review your exemption request and may contact you for additional information or clarification if necessary.

Please allow a reasonable processing time, and note that the final decision regarding your exemption request will be at the discretion of the relevant authorities.

Please note that, should Cabinet grant an exemption from Part 7 of the Act, that exemption may be subject to conditions. Further, the grant of an exemption does not:

- (a) give rise to any right to, or any expectation of a right to, any further exemptions or extensions in the future; or
- (b) confer any rights on spouses, civil partners or dependants with respect to residence and employment in the Islands.

Guidance notes for Exceptional Circumstances

- Critical skills shortage: Where the applicant/their prospective employer can demonstrate, by reference to relevant evidence, that the applicant possesses specific skills, expertise or qualifications which are essential to the economic or social development of the Cayman Islands but which are in short supply in the Islands and that they cannot readily be sourced from residents of the Islands to whom Part 7 of the Act does not apply or persons who are able to meet the requirements of Part 7 of the Act.
- National interest: When the employment of an individual is deemed to be in the national interest of the Cayman Islands, such as for projects of significant economic importance, national security, or public welfare and that individual would not otherwise meet the requirements of Part 7 of the Act.
- Exceptional talent or achievements: When an individual possesses exceptional talent, expertise, or achievements in their field that are internationally recognized, and their employment in the Cayman Islands would bring significant benefits to the local community or economy and that individual would not otherwise meet the requirements of Part 7 of the Act.

Compelling human rights grounds:

- o when there are compelling humanitarian reasons, such as cases involving medical emergencies or the protection of vulnerable individuals, which warrant a departure from the requirements of Part 7 of the Act, or
- o where, absent the grant of an exemption, an applicant would have to leave the Islands and this would result in a disproportionate interference with their private and/or family life, or that of their family members, amounting to a breach of section 9 of the Bill of Rights.
- o where, absent the grant of an exemption, an applicant would have to leave the Islands and this would result in a breach of another of their rights protected by Bill of Rights.

PRIVACY NOTICE:

The Cabinet is empowered under section 53(1)(b) of the Immigration (Transition) Act (2022 Revision) (the "Act") to grant exemptions from requirements set out in Part 7 of the Act. The Cabinet is supported by the Ministry with responsibility for Immigration and also by the Workforce Opportunities and Residency Cayman ("WORC") Department which enforces the Act. The Ministry and/or WORC will engage with other persons to process applications for exemptions under section 53(1)(b) of the Act. The information collected from these persons will not be shared with any unauthorised persons and/or organisations. However, the information provided will be reported to other Government agencies/Departments to obtain relevant information to assist Cabinet in making informed decisions on the exemption request application forms. The information collected from these application forms will be stored in WORC and/or MBCLC's secure databases authorised by the provider(s) and will adhere to the National Archive and Public Records Act (2021 Revision).
