**ABSOLUTE ORDER FOR BANKRUPTCY

UPON THE APPLICATION of the petitioning creditor, Associated Industries, Ltd trading as AI Rentals, and on referring to the Provisional Order made herein on the 28 day of January 2026;

AND UPON the petitioning creditor having rejected the Respondent's offer of payment of \$75,000.00 as more particularly set out in the Respondent's affidavit sworn 7 April 2026;

AND UPON this Court dispensing with a meeting of creditors, it being satisfied for the purposes of s.47 of the Bankruptcy Act (1997 Revision) that there is no reasonable probability of the confirmation of a deed of arrangement and that such delay will not be for the benefit of the creditors;
