PUBLIC LANDS REGULATIONS (2024 REVISION) REGULATION 5(1) - TEMPORARY CLOSURE OF PUBLIC LAND

The Public Lands Commission hereby notifies the public:

- that the registered 6 ft public right of way to the seashore from West Bay Road, along the south boundary of property Block 12E Parcel 54 known as beach access SMB 57 at Lacovia, is declared closed to public use, until no later than 15 December 2026.
- that the registered 12ft public right of way to the seashore from Prospect Point Road along the south boundary of Block 23C Parcel 199, known as beach access PP1, is declared closed to public use until no later than 30 November 2026.

In both instances the closure is to facilitate construction works.

Temporary closure of these public rights of way was approved by Cabinet on 16 September 2026.
