United States Visa Waiver Checklist

To apply for a Visa Waiver, you will need to submit:

- a) BOTC-Cayman Islands (CI) Passport – must be valid for 6 months beyond the date of intended departure from the USA
- b) Completed application form for a U.S. Visa waiver (overleaf);
- c) CI\$25.00 Cash/Cheque/Debit or Credit Card 3-4 business days or CI\$50.00 Express Service;
- d) Police Clearance Certificate – Required for all applicants 13 years and older, it is valid for 3 months but may only be used for one entry into the U.S
