



In exercise of the powers conferred by section 53(1) of the Development and Planning Act (2021 Revision), the Cabinet makes the following Order —

**Citation**

1. This Order may be cited as the Development and Planning (Waiver of Permission for Development) Order, 2025.

**Waiver**

2. The Cabinet, in the public interest, waives the requirement pursuant to section 13 of the Act to obtain permission to develop the land described in the second column of the Schedule for the corresponding purposes specified in the third column of the Schedule.

<b>4.</b>	<b>Block 96E Parcel 284</b> located at Cayman Brac Public Park in West End, Cayman Brac	For the development of a public restroom for the public and adjoining community
<b>5.</b>	<b>Block 99A Parcel 83</b> located at South Side West in Cayman Brac	For the development of a public restroom and nature park
<b>6.</b>	<b>Block 111E Parcel 96</b> located at Spot Bay Cemetery in Cayman Brac	For the development of a public restroom and ancillary facilities including clearing and parking

<b>8.</b>	<b>Block 95B Parcel 234</b> located at Cayman Brac Fire Service House in Cayman Brac	To carry out renovations to restore the building previously utilised by the Cayman Brac Fire Service House for accommodation and storage
