

1. These Regulations may be cited as the *Limited Liability Companies (Fees) Regulations (2025 Revision)*.

**Fees**

2. The prescribed fee for the item specified in column 2 of the Table of Fees in the Schedule is the amount specified in column 3 opposite that item.
